3. **APPLICANT'S RELEASE, ASSUMPTION OF RISK, AND AGREEMENT TO INDEMNIFY:** If I am chosen to participate in the 2018 Festival of the Vine Fine Arts & Craft Show: (a) I, for myself and my personal representatives, executors, administrators, heirs, successors, and assigns, release and discharge the Geneva Chamber of Commerce, the City of Geneva, Kane County and all sponsors of the 2018 Festival of the Vine Fine Arts & Craft Show, and each of their parent companies, subsidiaries, affiliates, directors, officers, trustees, officials, members, employees, volunteers, agents, attorneys, successors, and assigns, all referred to as "releasees," from all liability for any injury, damages, death, property damage, or other loss based upon, arising out of, or in any way connected with my participation in the 2018 Festival of the Vine Fine Arts & Craft Show, whether caused by any of the releasees' negligence or any other acts or omissions; (b) I agree to indemnify each of the releasees from any loss, liability, or damages which any of them may incur based upon, arising out, or in any way connected with any of my acts or omissions that relate in any way to the 2018 Festival of the Vine Fine Arts & Craft Show; (c) I assume full responsibility for the risk of any injury, damage, death, property damage, or other loss based upon, arising out of, or in any way connected with my participation in the 2018 Festival of the Vine Fine Arts & Craft Show, whether caused by any of the releasees' negligence or any other acts or omissions; and (d) I agree that the preceding paragraphs 3 (a) through (c) are intended to be as broad and inclusive as permitted under Illinois law and that if any portion of any or all of those paragraphs is held invalid, the balance of them and this agreement will continue in full force and effect. MEDIA SPECIFICATIONS: Arts & Craft - ***All items MUST be entirely the work of the exhibitor. Original work ONLY will be accepted.*** No kits, manufactured items, mass produced items or consignment pieces.

FEE: \$175.00 per space. Check Payable to Geneva Chamber of Commerce. A deposit of \$75.00 may be made at time of application with the remaining balance due by August 1, 2018. Returned Checks - \$20.00 service charge.

JURY PROCEDURES: Please submit 3 photos of your work with the fee, application form and a stamped, self-addressed envelope for the return of your photos. One photo must show an overall view of your display. Applications without photos and/or Illinois Sales Tax # will be automatically rejected.

JURY DATE / DEADLINE: **Wednesday, June 1, 2018 (or until filled).** Notification of acceptance will be made no later than **Thursday, June 30, 2018.**

Cancellation Policy: Written notice postmarked thru **July 15, 2018 – Full Refund.**
 Written notice postmarked **July 16 – July 30, 2018; 50% refund.**
 Written notice postmarked **after August 1, 2018 – No refund.**
